## Panelist Bios



**Julie Baker**, Executive Director, Californians for the Arts and California Arts Advocates (Sacramento)

As the Executive Director of California's statewide arts advocacy organizations since 2018, Julie has worked to increase the legislative clout and visibility of the arts and culture communities by building coalition across the for and non-profit sectors of California's creative industries, producing a month long arts awareness and advocacy campaign every April, and fighting for resources and legislation to serve and protect artists and cultural workers. She serves as the California State Captain to Americans for the Arts' National Arts Action Summit and on the State Arts Action Network Council and as the co-chair of the Western Arts Advocacy network for WESTAF. She is on the board of California Heritage: Indigenous Research Project, a founding member of the Nevada County Relief Fund advisory council and was elected to the Nevada County school board in November of 2020. Julie is the recipient of the 2021 Americans for the Arts Alene Valkanas State Arts Advocacy Award that honors an individual at the state level whose arts advocacy efforts have dramatically affected the political landscape.



## Jennifer Hark Dietz, Chief Executive Officer, PATH

A 15-year advocate in homelessness, Veterans, and mental health services, Jennifer leads PATH's strategic direction, business management, and personcentered efforts across California. She guides the organization's statewide initiatives, working alongside 900 staff with a shared commitment to establish permanent solutions to homelessness that are faster and more affordable. As the CEO, Jennifer manages the organization's assets, direct mergers and acquisitions, analyzes risk for new projects and programs, and coordinates legal issues. Under her leadership, PATH's programs statewide have increased by more than 20 percent each year, increased operations from \$15M to \$140M, and expanded its reach from 4,000 Californians across 90 cities.



**Dr. Le Ondra Clark Harvey**, Chief Executive Officer, California Council of Community Behavioral Health Agencies (CBHA)

Dr. Clark Harvey is a psychologist and the Chief Executive Officer of the California Council of Community Behavioral Health Agencies (CBHA). CBHA is a statewide advocacy organization representing mental health and substance use disorder non-profit agencies that collectively serve over 775 thousand Californians. She is also the Executive Director of the California Access Coalition- a group of advocacy organizations and pharmaceutical industry companies that advocates for patient access to behavioral health treatment. Dr. Clark Harvey has previously served as Chief Consultant to the California State Assembly Committee on Business and Professions, Principal Consultant to the Senate Committee on Business, Professions and Economic Development, and a health policy consultant to the office of former Senator Curren D. Price, Jr.



**Janet Marinaccio**, President/CEO, MEND-Meet Each Need with Dignity

Ms. Marinaccio joined MEND in July 2017, bringing 35 years of experience and leadership in both public and private sectors. Immediately recognizing MEND's role as a community anchor, Ms. Marinaccio has provided strategic leadership to sustain key programs and innovative responses to changing community needs. In the first 2 years, she led MEND's financial turnaround and established an operating reserve and Board-designated investment fund. With this new financial grounding, MEND has been able to survive and even thrive through the COVID-19 pandemic.

Ms. Marinaccio's nonprofit career is anchored in 16+ years at Goodwill Industries. She has developed and delivered programming for a wide variety of populations, including people with disabilities, veterans, those experiencing poverty and/or homelessness, those who are unemployed/underemployed/dislocated, ex-offenders, opportunity youth.
